## Sewer Bills

Alpine Township Board waived the penalty for the second quarter sewer bills because of the Coronavirus. This was for the second quarter ONLY! If you are paying your sewer payment electronically, please allow extra time for your bank to print the paper check and mail it. The third quarter sewer bills will be mailed July 1 and are due August 28.

## Tax Bills

The tax bills will be mailed July 1 and taxes are due September 14, 2020. We are suggesting that you use the black drop box at the west township door for payment, mail the payment, or you may always pay online (3% fee), either by calling the office or at our website ([www.alpinetwp.org](http://www.alpinetwp.org)). A one percent penalty is applied on any unpaid tax on September 15, and a one percent the beginning of each month is applied to the balance.

## EZ Pay

If you have E-Z Pay for your sewer and/or tax bills, please let us know if you are moving or changing account numbers. If you are interested in signing up for E-Z Pay, please call the office (616)784-1262 and a form will be sent to you.

## Fund Balances

The Township holdings are divided into five funds. The General Fund holds money for most types of Township expenses. The Water and Sewer Funds concern the freshwater and wastewater infrastructures in the Township.

The Trust & Agency Fund holds developers' and other businesses' deposits with the Township. The Capital Improvement /Restricted Funds holds money earmarked for future projects and maintenance in Alpine Township. The fund balances as of March 2020 are:

**TUESDAY, AUGUST 4, 2020** is the next election date.

At the present time, all six Alpine Township precincts **will be open** for voters on Tuesday August 4 which is the Primary Election. Using an absentee ballot to vote is another option. Absentee applications have been mailed to registered voters. At the State website you can obtain an application which can be printed/mailed or emailed directly to our office. You can also track your application and ballot on the site.

Now that you have been introduced to everyone, let me explain what these women and men do for you! ATFD provides fire, rescue, and emergency medical response services to the residents, businesses, and visitors of Alpine Township. In addition to answering alarms, the ATFD tries to be active in the community as much as possible. The ATFD performs duties such as; Fire Prevention at the local schools, community activities at the local "Big Box" stores, Apartment complexes, and Manufactured Home Communities.

ATFD's staff consists of one full-time chief officer, one full-time firefighter, one part-time administrative assistant, and 21 paid-on-call firefighters who offer a combined total of 317 years of experience!

These firefighters respond to alarms 24 hours a day, 7 days a week. Most of our firefighters respond from home. Fire Station-1 is staffed 7 days a week during daytime hours. In the event the ATFD gets an alarm that requires multiple firefighters, the response may be delayed due to the station not being staffed full-time, 24 hours a day.

These women and men train for many hours throughout the year in an effort to stay efficient in the skills necessary to handle an unfortunate incident that may occur anywhere in the infrastructure of Alpine Township.

The critical infrastructure of Alpine Township consists of chemical storage, farms that have large Controlled Atmosphere Storages (CA), three large apartment complexes, a railroad, two water towers, two-miles of "box store" shopping centers, three school districts, an American Natural Resources (ANR) natural gas pipeline, and an AT&T central office.

In this section, I would like to expand on the critical infrastructure of Alpine Township.

There are many different kinds of chemicals used and stored in Alpine Township, due to farming and industry, including CA storage rooms that use Anhydrous Ammonia as a refrigerant agent.

There are three densely populated apartment complexes that host 2,292 dwellings with 69 out of 87 buildings being three stories in height.

The railroad runs the length of the Township. It transports bulk commodities of various materials such as feed for animals to hazardous materials. The firefighters and fire officers of ATFD have been trained in emergency response to these types of incidents. Through continuing education, ATFD strives toward a common goal of being able to identify, promptly report, and responsibly address all environmental hazards pertaining to the railway.

Alpine Township also houses two water towers storing 1,000,000 gallons of water (which are part of a multi-township water system), including three townships and one city with a total coverage area of 46 square miles. A total of 13,600,000 gallons of water are stored at thirteen additional facilities, some of which are outside Alpine Township. In addition, there are 477 public fire hydrants in Alpine Township. These hydrants cover approximately 6 square miles with 30 square miles of the township being non-hydrant.

Alpine Township has a two mile stretch of large commercial "box store" shopping centers and strip malls (employing nearly 2,000 people daily).

There are three school districts in Alpine Township which include Comstock Park, Kenowa Hills, and Sparta. Kenowa Hills High School (KHHS), has five large assembly structures and a student enrollment of 1,111, K H Middle School, with a student enrollment of 705, and four Elementary Schools, with a student total enrollment of 1,155. The KHHS also has a Performing Arts Center that seats 750 people.

A portion of the privately owned ANR natural gas pipeline traverses the Township. The ANR pipeline includes three natural gas transmission lines ranging from 24” to 42” in diameter all running 750 pounds per square inch (psi). Transmission pipelines move refined natural gas from refineries to marketing and distribution terminals. This gas is delivered via pipelines through Alpine Township and is stored in underground fields off Kent County’s northern boundary.

Also located in Alpine Township is an AT&T central office. A central office exists to house the switching equipment that provides telecommunications service to the community, region, and nation. The telecommunications switching equipment processes all calls and signals within the local exchange and provides for interconnection to regional, national, and international networks. This electronic equipment performs signal processing operations and paths that include, but not limited to, switch and transport of audio, video, cable television, internet, U-Verse, broadband, wireless, and data signals.

The ATFD is asking for your support for the proposed millage specific to a new Fire Station along with full-time personnel, to be held in the November election. The ATFD wishes to be more efficient with our responses to the Alpine Township residents, businesses, and visitors. Having full-time personnel 24-hours a day will enable us to better serve our community. We appreciate and thank you for your continued support!

### EVERYBODY COUNTS! 2020 U.S. CENSUS

State Revenue Sharing is distributed to municipalities on a per capita basis (\$65.00 per person in 2010). By now you should have received a letter asking you to respond to the Census at "my2020census.gov". If an e-mail reply is not received by the Census Bureau, a reminder will be sent in April, a post card reminder will be sent in May. Finally a Census interviewer will make an in-person visit to your location.

Your response is important to Alpine Township and your country. By law, your response is required, and your answers are confidential.
